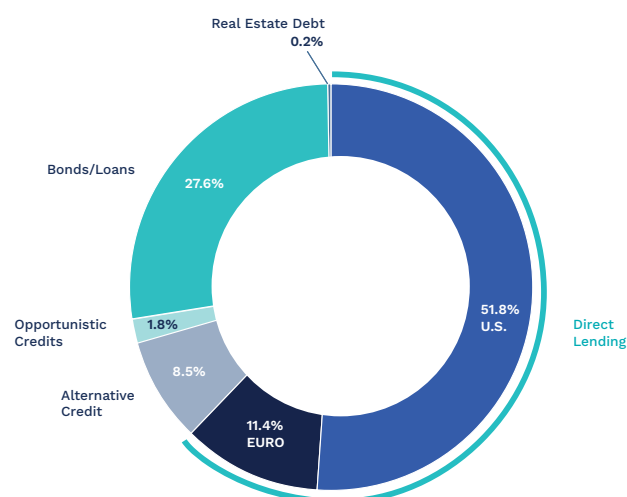
The fund offers true credit portfolio diversification*, which can potentially create a favorable risk/return profile with lower correlation to traditional public market investments.

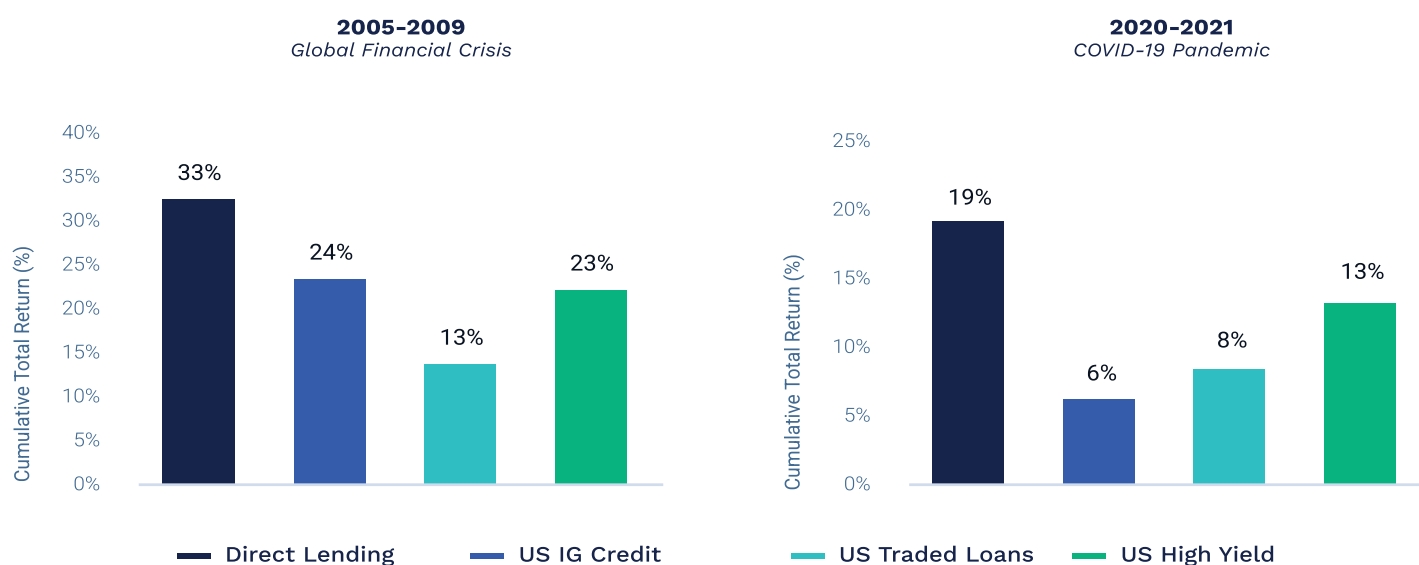
Why Diversified Credit, Why Now?



Volatility has Increased and Diversification is Challenging

Achieving adequate portfolio diversification has become more challenging as bonds and equities are more positively correlated and often move in tandem. Volatility has increased, and the economic and business cycles have moved into a new phase where risks are heightened.

How can investors develop their portfolios to navigate through this changing environment? Considering alternative credit assets may help.

Alternative Credit Is Redefining the Traditional Credit Portfolio

Alternatives are becoming mainstream and are often used alongside traditional investments, such as investment grade bonds, high yield bonds and leveraged loans, to build a well-diversified portfolio that can lower volatility while still meeting income needs.

These alternatives include illiquid private assets, such as direct lending, that do not trade on public exchanges. They also include private asset-backed securities and collateralized loan obligations.

The Challenge for Investors

How can investors incorporate this modern credit spectrum into a portfolio? Managing exposures across multiple asset classes can make risk difficult to quantify and understand. Adding private assets brings an illiquidity premium, but means tying up capital.

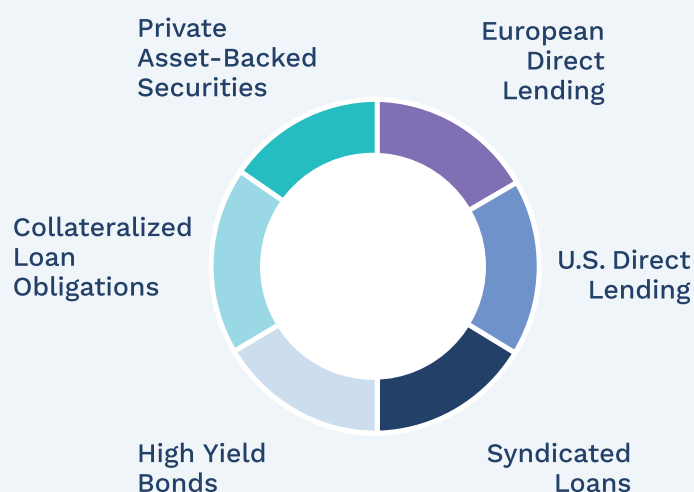
A Flexible, Diversified Alternatives Solution

A strategy that can offer exposure to a range of alternative credit assets, dynamically allocated in response to market conditions, and delivered in an accessible vehicle can be a viable way to incorporate alternatives.

The CION Ares Diversified Credit Fund strategy seeks to provide superior risk-adjusted returns across various market cycles. Maximizing current income is central to the investment philosophy. At the same time, because the strategy can hold assets that are not publicly traded, it may offer lower volatility than public markets and may reduce the correlation between equity and traditional bond holdings.

An Innovative Structure Provides Access

Solving the problem of access is also important. Private asset managers generally pursue a long-term strategy, whereas investors often need some liquidity. The limited liquidity requirement of the interval fund structure can be an effective compromise.

Risks

As with any asset class, there are certain risks associated with non-investment grade debt. Credit risk is the risk of nonpayment of scheduled interest or principal payments on a debt investment. The risk of default may be greater. Should a borrower fail to make a payment, or default, this may affect the overall return to the lender. Further, illiquid investments require longer investment time horizons than other investments. For these and other reasons, this asset class is considered speculative and may not be suitable for everyone.

An interval fund also can hold different types of assets, allowing the manager the flexibility to efficiently alter the asset allocation in response to market conditions.

| Diversified Credit: Five Key Reasons

- **Downside Management**

Portfolio consists predominantly of floating rate, senior secured loans underwritten by professionals across the Ares Credit Group
- **Yield Premium**

Seeks enhanced yield due to the premium associated with less liquid assets
- **Flexibility**

Managers identify and dynamically allocate to what they believe are the best relative value opportunities in credit
- **Low Correlation**

Asset classes have become increasingly more correlated over time, making diversification less effective against short-term market volatility
- **Diversification***

Well-diversified portfolio across credit strategies and issuer concentration levels seeks to provide optimal risk-return profile

Interval Funds

Interval funds must make periodic repurchase offers of no less than 5% of the outstanding shares at intervals of 3, 6, 9 or 12 months, and must hold enough liquid investments to cover them. This structure is a type of closed end fund, and has the features of transparency, low minimum investments, and simple tax reporting by Form 1099.

Offering Profile

FUND OBJECTIVE

To provide superior risk-adjusted returns across various market cycles by investing in a diversified portfolio of liquid and illiquid asset classes. The Fund seeks to capitalize on market inefficiencies and relative value opportunities throughout the entire global credit spectrum.

INVESTMENT STRATEGY

The Fund will invest primarily in a portfolio of directly originated loans, secured floating and fixed rate syndicated loans, corporate bonds, asset-backed securities, commercial real estate loans and other types of credit instruments which, under normal circumstances, will represent at least 80% of the Fund's assets.

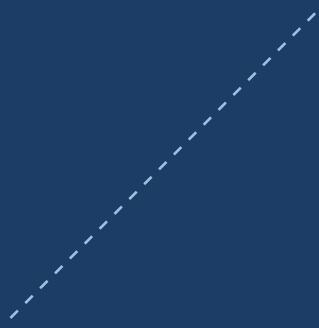
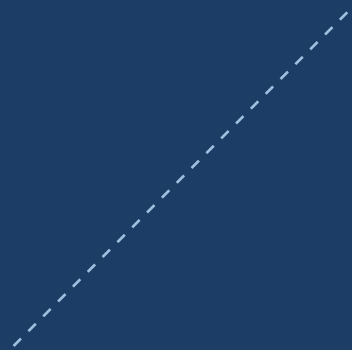
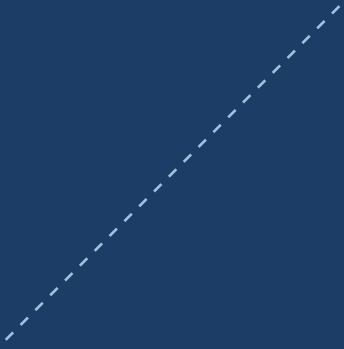
