A Different Approach to Tactical

The **Catalyst/Lyons Tactical Allocation Fund** offers an offense-first approach to tactical investing by holding full equity allocations for the long-term. Our two-pronged, targeted approach to defense allows us to make fewer shifts to bonds, which means more time spent participating in market upside.

Primary Goals & Key Reasons to Invest

Greater Upside Capture Potential: The Fund maximizes time spent in the market by holding a full equity allocation for multi-year periods during bull markets.


Seeks Reduced Downside in Bear Markets: We target any tactical shift in asset allocation to periods where risk of a sustained, damaging bear market is present.

Hedging Against Short-Term Risk: To address short-term headline risk while holding equities, we employ an event-based and technical-driven risk hedging program using options on market indices.

Alpha Potential: Our stock selection process has no style or other factor mandate, granting us flexibility to find optimal investment opportunities within our universe.



Glossary:

The Morningstar RatingTM for funds, or "star rating" is calculated for managed products (including mutual funds, variable annuity and variable life sub-accounts, exchange-traded funds, closed-end funds, and separate accounts) with at least a three-year history. Exchange-traded funds and open-ended mutual funds are considered a single population for comparative purposes. It is calculated based on a Morningstar Risk-Adjusted Return measure that accounts for variation in a managed product's monthly excess performance, placing more emphasis on downward variations and rewarding consistent performance. The Morningstar Rating does not include any adjustment for sales loads. The top 10% of products in each product category receive 5 stars, the next 22.5% receive 4 stars, the next 35% receive 3 stars, the next 22.5% receive 2 stars, and the bottom 10% receive 1 star. The Overall Morningstar Rating for a managed product is derived from a weighted average of the performance figures associated with its three-, five-, and 10-year (if applicable) Morningstar Rating metrics. The weights are: 100% three-year rating for 36-59 months of total returns, 60% five-year rating/40% three-year rating for 60-119 months of total returns, and 50% 10-year rating/30% five-year rating/20% three-year roting for 50-119 months of total returns. While the 10-year overall star rating formula seems to give the most weight to the 10-year period, the most recent three-year period actually has the greatest impact because it is included in all three rating periods.
