### A very open association






### PV installed in Italy



#### **DM FER1 Decree**

There are two different ways to access the incentives depending on plant capacity:

- **Registry** of installations with capacity between 20 kW and 1 MW (groups A for standard PV plants and A-2 for PV plants that replace asbestos roofing)
- Auctions for installations with capacity greater than or equal to 1 MW.

There are **7 calls** for participation in the Registries and/or Auctions, with the following timing

## **Energy Communities**

- The Italian Government has instituted Energy Communities as part of the «Milleproproghe» decree, based upon a proposal by ITALIA SOLARE and Legambiente.
- The decree regulates collective self-consumption from pv plants connected to low or medium voltage between people who consume in the energy community
- ARERA must now regulate the economic aspects of electricity produced and consumed within an energy community
- ITALIA SOLARE has submitted comments to the ARERA Consultation Document.
- Energy communities are an important part of the NECP's objectives.





### A proposal for installations on agricultural land

Ground-based photovoltaic installations are essential to achieve the NECP's 30GW photovoltaic target.

ITALIA SOLARE has presented a proposal to develop photovoltaic in agriculture/farming:

"part of the land surrounding residential centres and industrial/artisanal districts should always be dedicated to photovoltaic use, becoming an integral part of new urban planning plans with a view to the development of energy communities".

Agricultural enterprises should be seen as agro-energy companies, since PV represents an opportunity for agriculture and animal farming.

Given its capacity to attract investment and expertise, PV therefore represents an opportunity for many farms in financial difficulty today.
